General provisions

Article 1

RESEARCH PROJECT:

Efforts will be made to provide information about on-going activities in order to establish contacts and collaborations between professionals/organizations working within the same field. Research projects and the composition of research teams will be approved by the participating institutions. Efforts will be made to evaluate the need for participating staff and the localization of the research activity in question.

Article 4

ORGANIZATION OF HISTORICAL KNOWLEDGE EVENTS:

Both the institutions will work actively for the joint organization of historical knowledge events Like seminars, workshops, training & awareness programs, conferences, invited lectures, etc for the benefit of the students and staff of both the institutions with mutual consent.

The Historical knowledge events shall be organized on a regular basis at both the campuses involving staff and the students from both the institutions.

Article 5

PLACEMENT ACTIVITIES:

Both the institutions agree to work in full faith for the placement of successful candidates of C.B.Khedgi's College, Akkalkot and Jawahar Arts, Com., and Sci. College, Anadur Tal. Tuljapur.

DURATION/ MODIFICATION/TERMINATION:

This agreement will be valid for five years from the date of its signing and will be reviewed every five years and will remain in force until one or both the parties formally recommend(s) that it may be modified or interrupted.




