MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is made and entered into on this the day of 20.

BETWEEN

The Jawahar Arts, Science and Commerce College, Anadur, Tehsil Tuljapur, District Osmanabad - 413603 herein after call as JASCA, represented by the Principal, Jawahar Arts. Science and Commerce College, Anadur.

AND

The Osmanabadi Goat Farming and Training Center, Aliabad (OGFTCA), a statutory body created by an act of Parliament namely The Societies Registration Act, 1860 functioning autonomously as a 'Non-Government Organization' at Kaldev Limbala c/o sub center at Aliyabad (Naldurg), Registration No- 141/182/93 Osmanabad.

(Unless otherwise the context or meaning implies otherwise, herein after 'Institution' shall mean JASCA or OGFTCO, and both jointly referred to as 'Institutions')

The work areas of Osmanabadi Goat Farming and Training Center, Aliabad (OGFTCA), includes:

- i) Development of goat farming activities in and around Omanabad district.
- ii) Training of farmers, landless labours and emerging youths in goat farming and allied activities.
- iii) Implementation of various government schemes related to animal husbandary especially the goat farming with farmers and other stakeholders for the empowerment of rural areas and to help them develop allied sources of income.
- iv) Creating enterprenuearial opportunities related to the markets and supply chains of goat meat and its other byproducts.
- v) To see all money transactions are conducted in accordance with the rules in force.
- vi) To ascertain that the concerned employees and other member of the controlling staff are conversant with their duties, that discipline is maintained and the concerning works are properly supervised.
- vii) Successful implementation of the Plan Schemes within their work area.

Both the institutions are empowered by their bylaws to enter into cooperative agreements of this nature with other institutions, with regard to the subjects related to the achievement of its goals and objectives as stated by their bylaws, in order to further contribute to the achievement of such goals and objects.

Modalities of this activity shall be as follows:

The Jawahar Arts, Science and Commerce College, Anadur and **Osmanabadi Goat Farming and Training Center**, **Aliyabad (OGFTCA)** (individually as institution and together the "insitutions") desiring to develop cooperation and collaboration in the fields of enterpreneurship development, conservation, study, academic and research areas, agrees as follows:

- a) Regional survey and conservation of goat and other domestacitive animals.
- b) Celebration of Annual Dairy Goat Awareness Week.
- c) Study of different types of species of goats and their responses to variety of foodstuffs in accordance to the local climate reseliance focusing maximum productivity.

- d) Development of suitable and affordable goat production technology packages applicable in the rural areas and exchange of technical know-how. The thrust areas of intervention through collaborative R&D projects could be development and training of new methodoligies related to the subject of concern.
- e) Development of clusters in the traditional pasture areas and gazing communities through adoption of village and support to accelerate the technology dissemination process under the developmental programmes related to animal husbandary and production.
- f) Student Exposure Programme for short term intensive training/field visit/exposure etc. and dissertation/project work of the B.Sc. third year students for a duration upto 6 months. Boarding/stay facilities at consessional rates to be arranged at respective institutes.
- g) Designing curriculum to attract students to the area of goat farming management and byproducts development.
- h) To develop technological feed with great application potential, especially involving nanotechnology.
- i) Most importantly, training, skill development of rural students in goat farming and empowering them with novel enterprenueral methodologies.

Each organization will designate a co-ordinator under this MoU. The coordinators will exchange / meet as may be necessary to ensure appropriate cooperation under this MoU.

- 1. The execution of this MoU is subject to the availability of funds depending upon public funding and intramutual funding for both organizations, as well as to any legal provision in force governing the activities of the organizations. This MoU, therefore, does not consitute in any way a commitment of resources in the future or any future economic obligation.
- 2. The organizations, if they so agree upon, may allow the participation of other public or private insitutions whose activities directly impact the areas of collaboration, with the aim

- to strengthen and expand the mechanisms that support an effective implementation of this MoU. With prior approval of appropriaite authority form time to time.
- 3. The agreement could have a common IP management plan agreeable to both the institutions. Any patent arising out of the work proposed to be carried out under this MoU will be owned jointly by both the institutions.
- 4. During the tenure of this MoU, JASCA and **OGFTCA**, on behalf of its employees agree to maintain strict confidentiality of sensitive information and will not disclose the same to any third party. Disclosure thereof for any purpose other than in accordance with this MoU shall be a breach of this agreement.
- 5. The duration of this MoU shall be for a period of 5 years from the date of last signing which may be extended on mutual consent. The institutions/parties agree to review this MoU after 5 years from the date thereof. This MoU may be terminated at any time by either of the Parties/Institutions by giving 6 months written notice, but without dishonouring any commitment entered into the prior to the date of termination once and no party shall leave its commiment unfinished which may result in tangible losses of the other party.
- 6. It is recognized that the implementation of this document will in every case, be dependent upon the availability of necessary resources, either from within the institutions concerned or from external sources.
- 7. This MoU is not inteded to create legal or binding obligations on either institution. Any activity undertaken in furtherance of the objectives of this MoU will be incorporated into a formal separate agreement or agreements in good faith signed by the Institutions respective signing officers.
- 8. Settlement of Dispute:-

Any difference and dispute between parties concerning the inerpretation and implementation shall be settled amicably, through mutual understanding.
