JAWAHAR ARTS, SCIENCE & COMMERCE COLLEGE PRECISION CAMSHAFTS LIMITED, SOLAPUR has emerged as one of the market leader in Camshaft manufacturing. - d) To enable a congenial atmosphere for mobilization of the trainees/students.

- e) To assist for promotional support so as to publicize the initiative for skill development and to facilitate mobilization of trainees.
- f) To assist provision for training equipment as and when required.
- g) To develop the infrastructure.
- h) JAWAHAR ARTS, SCIENCE & COMMERCE COLLEGE, ANADUR being esteemed training institution will play as knowledge partner for PCL.
- i) JAWAHAR ARTS, SCIENCE & COMMERCE COLLEGE, ANADUR will undergo the NSQF aligned UGC & Dr. Babasaheb Ambedkar Marathawada University, Aurangabad's courses.
- j) JAWAHAR ARTS, SCIENCE & COMMERCE COLLEGE, ANADUR will arrange Training of Trainers.
- k) There will be no financial role of PCL in arrangement between JAWAHAR ARTS, SCIENCE & COMMERCE COLLEGE, ANADUR and the Industry body.
- I) JAWAHAR ARTS, SCIENCE & COMMERCE COLLEGE, ANADUR will pay the assessment fee/honorarium to PCL, where ever & when ever it is necessary.

#### **Roles and Responsibility of MESC**

- a) To assist JAWAHAR ARTS, SCIENCE & COMMERCE COLLEGE, ANADUR in aligning the curriculum with the identified Automobile Sector and national occupational standards for B-Voc, / BSC, and other Course Curriculum related to Automobile Industry.
- b) To facilitate training of trainers and help in provisioning of Master Trainers from the industry, on as required basis.
- c) Develop industry linkages to enable the students to have practical training and skill development on the job.
- d) To ensure quality of training delivery by adopting a stringent accreditation process for training service providers, assessments and certification of trainees.
- e) To conduct In-Plant Training and issue certificate.
- Assessment will be carried out as per the QP progression matrix aligned to NSQF.

## Duration/ Term of the MoA:

- a) MOA shall be valid for three (3) years from the date of it's entering into and may be mutually extended from time to time in writing by the parties.
- b) This Memorandum of Agreement is a document of good faith and Implementation of the MoA would be monitored on a six-monthly basis.

## Changes / Amendment:

No change can be made to this MoA without written consent and duly signed by all the parties. Additions, deletions and/or alterations to this MoA may be affected with the written agreement of all the parties to this MoA concerning the changes. Documents containing such additions, deletions and/or alterations and signed by all the Parties shall form addenda to this MoA and be deemed to be part of this MoA.

#### Termination:

The parties can terminate this MoA after serving 3 (three) months' notice in writing if there is failure/ breach of understanding or default by either party other than on force majeure grounds. At the time of termination neither party shall be liable to other hereunder or in relation Veto for more than the fees paid, including the amounts invoiced but not yet paid.

#### Force Majeure:

Neither party shall be liable to the other for failure or delay in the performance of any of its obligations under this MoA for the time and to the extent such failure or delay is caused due to acts of God, natural disaster, fire, floods, explosions or earthquake, epidemic or quarantine restrictions, serious accidents, war, insurrection or riots, strikes, legal necessity or labour troubles, or any other cause beyond the affected party's reasonable control, provided that sufficient notice of such occurrence of force majeure is communicated to the other party.
